



After coming off of two years of heavy mitigations for Covid-19, we were grateful to relax our guidelines significantly, bringing us to a place similar to where we were before Covid affected our world. We thank everyone for adhering to the mitigations throughout the time they were necessary and still making sure that we continue to be a place which encourages health and wholeness for all of our members.

It's been encouraging seeing the number of activities and participants increase throughout 2022. On a number of Sundays throughout the year, our attendance has grown to nearly 100 in worship. We continue to stream on Facebook, YouTube, on our website, and broadcast on Jubilee 690am. While our members are away, healing from illness or surgery, or not able to attend in person, they are able to watch our Sunday worship services. This has also been a wonderful tool to share the Good News of God's love and grace in our world. As a reminder, you can go to Facebook or to YouTube to find previous services if you would like to rewatch a portion or all of a service.

As the Capital Technical Improvement Project (CTIP) came to a close, the quality of sound and light in the sanctuary and other spaces was greatly upgraded. In Heritage Hall, the acoustic panels technology and various spaces in our church improved the way we could hear one another in meetings and other events. Once again, thank you to everyone who gave to the project!

This year, thanks to our tech team, we were able to host hybrid congregational meetings in which our members could join the meeting remotely. Our members who were not able to be present in person have the option to attend meetings through Zoom.

Early in 2022, a core team of congregants began working with Dr. Lisa Withrow with Clear Transition Strategies. While some time of reflection led us to pause the project in the summer of 2022, the process became recharged again by autumn. I felt called to create worship and activities around the theme of kindness for 2023, and this theme is being incorporated as part of the process. We also have some focal points which will be shared more in the near future.

During this year, I had the chance to lead a study and sermon series on the Statement of



Faith. I also helped out with the Tuesday morning Bible Study and led an Advent Study on the hymns of Advent. Our Social Justice book study met earlier in the year; we will look to see how we can begin this study again in 2023.

Stewardship continued the 50/50 raffle and included other fundraisers including the Cardinals baseball game and the return of Trivia Night (Thanks to Michael Wagner, our host!). We thank the Hoffmanns for hosting Margarita Monday at their home again this year. Also, we

thank everyone who hosted a St. Paul Friends event this year as we are grateful to be back socializing with our dear St. Paul friends at fun-raisers!

Our Christian Education team helped to organize and lead the VBS program "Food Truck Party" in June. It was wonderful working with Trinity UCC on VBS this year! Besides leading our team them through the process, I helped them choose the curriculum.

I continue to work with the youth on our monthly gatherings. I have enjoyed working with them on creating and leading worship!

The With You group, of which I'm a part, met consistently on the first Wednesday of every month throughout this entire year to discuss the needs of some of our congregants. I update the team as information becomes available. This has been a program that continues to expand and be a blessing to our members. I am leading communion once per month at St. Paul Senior Community during the worship service. We welcomed new members in September.

I am grateful for the establishment and regular meetings of the Pastoral Relations Committee.

Throughout the month of September, I held community office hours at various locations around Belleville. We continued our outreach efforts with events like the Alzheimer's Walk and Metro East Pride. Both with our Pride booth and the Shriner's Parade, we join efforts with Trinity UCC to promote our churches. I've attended a number of Belleville Chamber of Commerce events around town and have set up a Coffee Cup Connections for March 14, 2023.

I led 12 funerals and one baptism. We were saddened by the many losses, including our staff member Donna Young. We took time to wish Stephenie Bauza a happy retirement. Additionally, we welcomed Kathy Buehler, Ian Hipkins, Mary Blaies, and (welcomed back) Dr. Tristan Frampton to our staff.

I engaged in ecumenical and intradenominational work during the year as well. I am coordinating a group of Mainline Protestant clergy meeting each month at The Abbey. I served on the WISE discernment committee through the Illinois South Conference and presented at the Annual Meeting for the initiative. I also started co-chairing the Justice and Mission Team of the conference. I have helped to create worship for the United Church of Christ denomination and am currently helping to write liturgy for General Synod. I was also elected to be a delegate to General Synod in 2023.

For my own continuing education I attended the Festival of Homeletics in Denver in May 2022. Additionally, I had written materials in the *Abingdon Worship Annual 2023* which was released in 2022.

Shoutout to Rev. Merrimon Boyd in the spring as well as Rev. Shana Johnson who helped to lead services while I was recovering from surgery! And thank you to our lay leaders who helped to lead a couple services while I was on vacation.

As we joyously look ahead embracing the dreams of God, we know that God is with us as we vision together. I feel extremely blessed to be your pastor, and I look forward to the ways we are calling us to grow together in 2023!

Tristan Frampton Music Director

It has been an eventful, fulfilling, and challenging year for our music ministries here at St. Paul. Tristan Frampton was hired as the music director and started working with the Sanctuary Choir and Glory Ringers in February, just before Lent. It had been decided that the position of music director would be split to allow for a choir director and an organist. Our search for a permanent organist proved fruitless for quite a while. But our patience paid off. A stellar organist applied and accepted our offer to come and work with us. Continued patience is required, as he is not relocating to the area until May or June, but he is well worth the wait! In the meantime, we will continue to hire guest organists and pianists to play for worship. Not having a regular organist, it was determined that focusing on quality music offerings was more important than presenting complicated programs, like Christmas cantatas. But the focus on musicianship, ensemble, and tone has clearly proved valuable. Our ensembles are sounding great, and their music has contributed much to our worship services.

The Sanctuary Choir and Glory Ringers practice weekly during our regular "season," which generally follows the academic calendar. The Sanctuary Choir provided anthems for worship weekly, and we incorporated the handbells into worship when the schedule of our ringers permitted. It is the hope that the Glory Ringers will be able to ring more regularly in the new year.

We have started to have more youth-led worship services. This included special music provided by some of our musically talented young members. We even had a Sunday during Advent when some of our youth, along with additional members of our congregation, provided impromptu, improvisatory handbell ringing that complemented one of our choir anthems. It is alway nice to see our youth involved in worship and in music-making.

We have had several challenges this year, some of which are ongoing. As previously mentioned, we do not have a regular organist on staff. While this has been difficult in terms of repertoire programming and organization, we have made due scheduling guest organists. Janet Spencer has been invaluable in helping to put us in touch with talented individuals. She has also filled in at the organ bench when needed. Our regular organ technicians have retired, so we needed to find a new organ technician to maintain our beautiful instrument. Janet was instrumental in finding a satisfactory replacement. Another challenge is that our rehearsal piano in the music room is in poor condition. Our piano technician, Greg Junker, reported that it would be more expensive and time- consuming to refurbish the instrument than it would be to find a new piano, or a used one in good condition. St. Paul Fine Arts has graciously taken up the charge to find and fund the purchase of a piano for our rehearsal space.

Despite the challenges of the past year, we have continued to make good music here at St. Paul. We had organ and brass to celebrate Easter with glorious and triumphant tones. Our Sanctuary Choir and Glory Ringers provided wonderful music for Advent and Christmas seasons. On Christmas Eve, at the 7:00 PM worship service, the Sanctuary Choir performed

two pieces arranged by our music director, Tristan Frampton, and helped lead some of our most beloved carols. Tristan provided special music during the 4:30 PM Christmas Eve service, singing O Holy Night with Janet Spencer. We enjoyed a more informal Christmas Day service in Heritage Hall, during which we had special music provided by Jack W. and guitarled congregational singing of Christmas carols.

All in all, it has been a wonderful year of music-making in service to our church and to God. Our ensemble members are in good spirits, we have a new organist that will be joining us in June, our musicianship has improved, our musical offerings are well- received on Sunday mornings, and there is excitement about things to come. It has been a good year in the life of the music ministries here at St. Paul.

Ian Hipkins Technology Coordinator

During the last seven months that I've been hired as Tech Coordinator, I had the experience of running the sound booth which holds the sound mixer, and computer that streams to OBS which streams to YouTube and Facebook. I also seized



the line for the radio which is upstairs in the radio room. All of this for the first month was under the supervision of Richard Haar.

Other responsibilities of mine is I put together slides, play audio or videos, and set up audio equipment for events as well. As Tech Coordinator, I had to order equipment to fulfill certain requirements that were needed such as microphone adapters for the children's pageant in December. Also it's my responsibility to organize the volunteers and create their schedules for each month as well as training them, fixing anything that breaks, and helping them with whatever they need.

One of the more important responsibilities that I handle is trying to implement new ideas that are given to me in terms of setting up other equipment. One such idea is getting the TV in the welcome center to play videos and slideshows for images. Some ideas are more feasible than others, and I try my best to attempt as many as possible.

There are certain issues that I have come across while being Tech Coordinator, the most recent one is the choir monitors not working properly, but these issues are not permanent, and myself along with Richard Haar will investigate and fix them. Another issue is sometimes Google will automatically sign out of our account while mid-service, or perhaps YouTube decided to not stream. These are only minor issues, and they rarely happen and can be avoided easily.

Overall, there have been no long term issues, and everything runs smoothly for the most part. The volunteers have been fantastic, and have always been helpful and It's been my pleasure to work with them.

The main priority that is my focus in 2023 is going to be fixing and maintaining the systems that are in place, as well as learning more about how to be more efficient as a Tech Coordinator.

Serving on the Finance team were Wayne Kniepkamp, Dana Rosenzweig, Mike Pierce, Terry Kalinowski, Stephenie Bauza, Laurence Walton, Ken Nettleton (advisor, resigned in mid-year) and Staff Liaison Kathy Buehler. Stephenie and Kathy joined the Team mid-2022. The Team coordinated with other Church Teams to control expenses during the year. Fiscal controls and spending approvals put in place in previous years were continued and implemented. We wanted to protect our core investments in the Endowment Fund.

The FY2023 budget was prepared based on previous years expenditures and realistic revenue expectations. The various Church Teams provided solid input into the process. Some difficult decisions were made to strengthen the Church. The Church Bookkeeper and the previous Church Accountant worked together to prepare the final document.

Congregational offerings for FY2022 were \$383,640 which were \$4,440 above budget projections for the year which was outstanding. Our total operating revenues at close of year were at \$569,780.

Our operating expenses for FY2022 were \$572,345. And the difference between operating revenues and expenses for 2022 was \$2,569 in the red.

As of December 31, 2022, our investment funds were \$1,699,635 in the Endowment Fund and another \$355,355 in the Michelson fund. Loss of value of the core Endowment Funds due to a difficult investment market were offset by an infusion of \$223,402 from the St. Paul Home Foundation in November.

A distribution of \$39,035 was made from the Endowment Fund for capital improvements.

The highlight of FY2022 was that we did not have to withdraw any funds from the Endowment Fund for operating expenses as we did for the previous five years. We were originally budgeted to withdraw \$98,500.

We received \$14,845 in memorials. Personnel costs were 85 percent of budget due to personnel changes.

As of December 31, 2022, we have \$36,963 in the bank plus another \$55,668 of various designated funds.

We would like to thank all Church Teams for their efforts in keeping costs down during 2022. We would also thank all members of the Church for their continued generosity that enables the S. Paul UCC to remain in a strong financial position.



The major activity of 2022 involved filling vacancies by hiring five new employees. The vacancies resulted from resignations, death, and retirement.

Following the resignation of our Music Director in January, a search committee was appointed in January. The committee recommended the splitting of the position into two positions—choir director and organist. Tristan Frampton was hired as choir director in February. An organist was hired in August and will begin work in Summer 2023. We have had excellent help from substitute organists Jan Spencer, Robert Chamberlain, and Andrzei Zahorski throughout this time.

With the resignation of our Technology Coordinator in January, we advertised the position and conducted interviews. In the meantime we had volunteers and Evan Wilhelm serving as interim coordinator. We advertised the position, conducted interviews and hired Ian Hopkins for the position in June.

After 6 1/2 years of dedicated service working on our finances, accounting, and budget, Stephenie Bauza retired as Bookkeeper. We advertised the position, conducted interviews and hired Kathy Buehler as Bookkeeper in June.

In August we grieved the passing of our loyal and conscientious Receptionist, Donna Young. In November, as recommended by our team and the Church Council, we advertised and conducted interviews for the position of part-time custodian that could also help with receptionist duties with groups using our facilities. We hired Mary Blaies for this position in November. She will be helping with community activities in Heritage Hall and activity center. She will work Sunday mornings, and as needed during the week.

During the year, in evaluating our needs based on the present size of our church membership and attendance, we recommended to the Church Council that we not replace the positions of Director of Faith Formation and Director of Non-Traditional Music. The Visioning Committee is working on recommendations and needs for the future work of our church.

After a successful year of Mothers' Day Out under the volunteer leadership of Sue Hoffmann with volunteer helpers, it was decided to discontinue the program for 2022-2023 due to lack of enrollment and support.

We had substitute pastors in February when Pastor Michelle had surgery.

We oversaw the completion of staff evaluations and conducted the annual review of the Pastor.

We worked on filling vacancies on the Pastoral Relations Committee.

We had input from all of the staff regarding their jobs, working conditions, and any suggestions or concerns they had.

We worked with the Budget and Finance Team and Church Council on staff salaries for 2023. We considered the cost of living increases during the past year, the current job market, and aimed to ensure that our staff is adequately compensated for their high quality of work.

Property Team

Business, Property & Security Year End Report for 2022

2022 is now in the novels of history.....We had some major ups and some major downs, and have prevailed!

After 2 ½ years of waiting, we were able to dedicate Heritage Hall in May. It was a beautiful day and a lovely dedication. Everyone came together to admire the work of all that so graciously donated their time and talents. Special thank you to the contractors, Dave Hoffmann, Roger Harris and Patrick Kinney!

A major addition to the main sanctuary was the new sound booth and the ability to have it finished to look like a part of our beautiful-mid century interior. We were able to match the white oak used in the rest of the church, allowing it to blend in, like it was always there! We also had the opportunity to hire a tech team member, Ian Hipkins, who has proven to be a valuable team member.

We added sound panels to the face of the old choir railing area. They blend in so well, that no one even knows they are there!

We put new cameras in the main sanctuary to help with security situations. We added a closed circuit monitor in the kitchen for the Culinaires and are currently looking to add speakers that are loud enough to be heard over the cooking equipment.

The BEST thing that we did this year was have Patrick Kinney install the acoustical panels on the walls in Heritage Hall, which finally make it a space that people can have a conversation, without the echo. This will allow groups to gather for services or performances and be able to understand!

We installed new aluminum framed commercial exterior doors to the Activity Center. The original ones were heavy and the mechanism had failed, forcing the need to replace them.

The Security Team joined Business and Property again this year, as they have a good deal to do with the "Property" and this has worked out very well. The team, with Patrick has made our building a much more secure place during services and during the week. We owe them a good deal of credit for keeping us safe. The yearly orientations that Dave Hoffmann provides are a God send. The world is a different place, unfortunately, and this team is definitely necessary.

Another positive thing was the addition of Mary Blaies, and our relationship with St. Clair County Center for Aging. Because of her, we now have an active Pickle Ball group that uses the activity center daily, and a YOGA group that is able to use Heritage Hall. Another relationship that works well with our facility.

We are still in a successful relationship with BASSC and the house they rent from us, across the street. We needed to replace the wooden ramp to the front door this year, and we were able to do this "in-house" avoiding a sub contractor to do the expensive labor. The BASSC organization is very easy to work with, and we hope to continue this in the future.

The "PIT" as it was once known, where the original organ console sat, then the sound booth. Once we built the sound booth on the main level, there was then a large opening in the floor. Patrick was able to build the flooring up to be level and no hazard to anyone walking in that area.

After coming off a fantastic wrap up to the Sanctuary Technology upgrade with the sound booth, and lighting additions, we were hit hard with some news regarding the very old electrical panels that had to be repaired. We retrofitted the panels that required immediate attention at the beginning of 2022.



Then, later in the year we were told that more panels had to be retrofitted. We had to obtain money from the endowment for this sizable expenditure. The congregation voted to move forward with the repairs.

They say bad things come in threes.....well, it did. We also lost the AC unit for the activity center. Thankfully, this happened towards the cooler part of the end of the year. We purchased the new unit, and it will be installed once there is a decent break in the winter weather.

We had some exterior issues with gutters, painting of the portecochere columns, and in typical "Patrick" fashion, he was on top of it and took care of everything in a very timely manner. We are

so lucky and blessed to have this wonderful benevolent soul working with us. We would be

lost without him. Thank you Patrick Kinney!

The good balanced out the bad. We all are thankful for the guidance of our past president, Dr. Steve Schmitt, and his unrelenting dedication to his position as Church Council President. His inspiration is a blessing.

On to 2023! Hopefully the Emergency Spending is over.....for a while!

Delegate to Illinois South Conference Report

Day of Discipleship

Due to COVID-19, the Day of Discipleship was held on March 19, 2022 via Zoom. The Townhall meeting gave us the opportunity to hear updates from:

- The WISE exploratory team
- The Dubois 6.0 campaign
- The ISC Hunger Action Team
- Uni-Pres Kindercottage's new Executive Director

During the first session, I attended Workshop #1: **Healthy Communication** by Rev. Lisa Hart, Intentional Interim Pastor at St. John UCC, Chesterfield, MO.

She spoke of how the interim will help the congregation through the process of preparing for a new pastor. Communication is needed by everyone. It needs to be clear and concise. Confidentiality is important, as well. Permission is needed to put someone's name on the prayer list or to share information with the congregation. The interim needs to take time to work through things with the parishioners and to keep them informed. Praying for the new pastor regularly is very important.

During Session Two I attended Workshop #2 **Pathways to Promise: A Taste of Companionship**. Rev. Tim Darmour-Paul, Pastor at Grantfork UCC led this workshop. The Companionship Model is a program which teaches members of the congregation how to build a circle of care with individuals who are facing emotional and mental health challenges. Companionship recognizes the need for a circle of care and support. We are not there to heal, but to be present and listen.

Annual Meeting 2022

The Illinois South Conference annual meeting was held on October 15, 2022. It was hosted by St. John UCC in Collinsville, IL.

Throughout the day, we were treated to the music of "The Many". Their music encourages "people to sing together about peace and justice and a world where all belong". The Marketplace provided an opportunity to learn about our ministry partners and to purchase resources from Eden Theological Seminary bookstore and products from Fair Trade and SERRV.

During the morning plenary session, a presentation was given on becoming a WISE conference and/or a WISE congregation. WISE stands for Welcoming, Inclusive, Supportive and Engaged when referring to those in our churches who are dealing with mental health challenges and the people who love them. In the afternoon session, this was voted on and approved.

There was also a discussion about the Divestment of Fossil Fuel. The fossil fuel industries, by extraction of oil, gas and coal focus on monetizing these resources in order to benefit a few companies and stockholders. The resolution urges the Illinois South Conference of the UCC, its congregations and individuals to divest from fossil fuel companies. A vote was taken later in the afternoon and the resolution was approved.

The 2023 budget was presented, voted on and approved.

The slate of nominees for 2023 was presented, voted on and approved, as well.

An update was given on the DuBois Center and DuBois 6.0. Offerings were collected for DuBois Center 6.0 as well as for Disaster Ministries of the UCC.

Before adjourning for the day, the attendees participated in Closing Worship with Installations and Communion.
